California's unemployment rate decreases to 6.9 percent

California's unemployment rate decreased to 6.9 percent in January, and nonfarm payroll jobs increased by 67,300 during the month for a total gain of 1,806,700 jobs since the recovery began in February 2010, according to data released today by the California Employment Development Department (EDD) from two separate surveys.

The U.S. unemployment rate increased in January to 5.7 percent.

In December 2014, the state's unemployment rate was 7.1 percent, and in January 2014, the unemployment rate was 8.1 percent. The unemployment rate is derived from a federal survey of 5,500 California households.

Nonfarm jobs in California totaled 15,928,000 in January, an increase of 67,300 jobs over the month, according to a survey of businesses that is larger and

less variable statistically. The survey of 58,000 California businesses measures jobs in the economy. The year-over-year change, January 2014 to January 2015, shows an increase of 498,000 jobs (up 3.2 percent).

The federal survey of households, done with a smaller sample than the survey of employers, shows an increase in the number of employed people. It estimates the number of Californians holding jobs in January was 17,620,000, an increase of 54,000 from December 2014, and up 441,000 from the employment total in January of last year.

The number of people unemployed in California was 1,316,000 – down by 31,000 over the month, and down by 194,000 compared with January of last year.

EDD's report on payroll employment (wage and salary jobs) in the nonfarm industries of California totaled 15,928,000 in January, a net gain of 67,300 jobs since the December survey. This followed a gain of 19,800 jobs (as revised) in December.

Eight categories (construction; trade, transportation and utilities; information; financial activities; professional and business services; educational and health services; leisure and hospitality; and government) added jobs over the month, gaining 72,300 jobs.

Information posted the largest increase over the month, adding 14,000 jobs.

Three categories (mining and logging; manufacturing; and other services) reported job declines over the month, down 5,000 jobs. Manufacturing posted the largest decrease over the month, down 4,200 jobs.

In a year-over-year comparison (January 2014 to January 2015), nonfarm payroll employment in California increased by 498,000 jobs (up 3.2 percent).

Ten categories (construction; manufacturing; trade, transportation and utilities; information; financial activities; professional and business services; educational and health services; leisure and hospitality; other services; and government) posted job gains over the year, adding 498,300 jobs. Professional and business services posted the largest gains on numerical basis, adding 111,900 jobs (up 4.7 percent).

Construction posted the largest gains on a percentage basis, up 5.7 percent (adding 37,800 jobs).

In related data, the EDD reported that there were 397,142 people receiving regular Unemployment Insurance benefits during the January 2015 survey week. This compares with 436,034 in December and 495,273 in January of last year. At the same time, new claims for Unemployment Insurance were 40,989 in January 2015, compared with 47,858 in December and 73,040 in January of last year.

While supporters of changing Proposition 13 to increase taxes on commercial property usually focus on raising the tax rate or frequently reassessing property, UCLA Law School professor Kirk Stark has a different idea – broaden the base of business property taxes by reassessing more often but at the same time lower tax rates on property and other business taxes. Stark made the proposal yesterday in Los Angeles at a panel discussion on the split roll that also featured Jon Coupal, president of the Howard Jarvis Taxpayers Association and Gina Rodriquez, vice president of the California Taxpayers As-

sociation. The event was sponsored by the Bisnow website, which covers people and projects in the commercial real estate business.

Stark suggested reassessing property on a regularly scheduled basis but lowering the 1 percent tax rate, eliminating property taxes on business equipment and reducing other business taxes. Stark said his goal was to harness the impulse to tweak Proposition 13 and gain sound tax policy rather than ratchet up the tax burden.

However, proponents of the split roll are after more money and lowering a series of other taxes doesn't fit into the game plan. Nevertheless, Stark's proposal in another in a line seeking changes to Proposition 13.

Cal-Tax's Rodriquez argued there was no need to change any aspect of Proposition 13. She said there has been no shift of the property tax burden from commercial property to residential property, citing the fact that residential properties which claim the homeowners exemption saw property taxes increase by 6.8 percent since Prop 13 passed compared to commercial property increasing 7.3 percent over the same period.

Rodriquez added that under Proposition 13 property tax is the most stable tax in the state and it produces growing revenue for local governments.

Jon Coupal from the Howard Jarvis Taxpayers Association agreed, pointing out that assessor officials around the state noted that because of the Proposition 13 tax system, which produces steady rising revenue even during difficult economic times because of the way it functions, counties were spared "horrible damage" during the Great Recession.

Coupal said California government is not starving for revenue, as tax increase proponents would have you believe. He said California has the highest income tax in the nation, the highest sales tax, the highest gas tax even before the inclusion of cap and trade fees and property taxes that are ranked in the top half of all states.

The issue of when a business property changes ownership triggering a reassessment of property under Proposition 13 re-

ceived much attention during the discussion.

Stark complained that the Prop 13 system allows legal entities to own commercial property making it difficult to determine a change in ownership. He mentioned the highly publicized case of a Santa Monica hotel purchased by computer entrepreneur Michael Dell, his wife and others without anyone getting 50-percent of the purchase denying a change of ownership reassessment which a court found legal.

Coupal told of a legislative bill authored by two Democrats last session aimed at reigning in abusive transactions under change of ownership statutes such as the Dell case. The bill failed, Coupal said, because public labor unions urged defeat of the bill as they want a full-blown split roll to change Prop 13, not a corrective fix of the statutes.

Coupal argued there are no loopholes in Prop 13 as critics charge. Proposition 13 calls for reassessment on change of ownership. The legislature wrote the rules on how that occurs, so legislative statutes are at the center of the change in ownership discussion, not the article put in the constitution by Prop 13.

CAMP (Community and Meeting Place) was the most exciting addition to this year's event, providing Modernism Week revelers with a central location to meet, shop, dine, learn, and relax between tours and parties. Ferguson, the exclusive Kitchen & Bath Sponsor of Modernism Week, produced a series of panel discussions at CAMP titled "Renovation Insights," and also sponsored a Design Industry Party at the Modernism Week Show House 2015: The Christopher Kennedy Compound, which experienced a 20 percent increase in attendance over its inaugural 2014 event with a total of 3,000 visitors during the festival. The Modernism Show & Sale at the Palm Springs Convention Center also broke attendance records with more than 8,350 visitors during Presidents' Day weekend, an increase of more than 10 percent over last year. Exhibitors included a selection of 25 dealers from 1stdibs, the online luxury marketplace and Modernism Week Premier Sponsor.

A highlight of the week was 'Poolside Gossip: an Evening with the Ladies from the Iconic Photograph' On Thursday, Feb. 19. Though the program was intended to be a conversation with Nelda Linsk and her decades-long friend, Helen Kaptur, reuniting the ladies who appear sitting poolside at the 'Desert House' in the 1970 Slim Aarons photo, Kaptur died earlier that week after a brief illness. Helen was the wife of acclaimed architect Hugh M. Kaptur, AIA. The enraptured and nostalgic audience listened intently as Linsk reminisced with Modernism Week board member Gary Johns about owning and living in the Richard Neutra-designed Desert House, sharing photographs and anecdotes about her life in Palm Springs when the legendary photo was taken. Internationally acclaimed modernist architect Neutra was also recognized during Modernism Week with a special dedication ceremony on the Palm Springs Walk of Stars.

Twenty-three neighborhood organizations, including 11 participating in Modernism Week for the first time in 2015, offered tours featuring homes that have been lovingly purchased, restored, and landscaped, often by past attendees of Modernism Week. Tour revenue increased 111 percent over last year, generating more than \$463,000, for the neighborhoods to fund improvements such as landscaping, signage, restoration, and charitable contributions. Modernism Week also conducted a special Premier Double Decker Architectural Bus Tour for area high school and college students, and provided opportunities for students to attend lectures and participate in other events.

Partner events co-produced during Modernism Week proved to be effective fund-raising, bringing in more than \$900,000 to fortify the participating neighborhoods, other preservation groups including Palm Springs Modern Committee, Palm Springs Preservation Foundation, and the Palm Springs Historical Society, as well as Palm Springs Art Museum, Mizell Senior Center, the local chapter of American Society of Interior Designers, and other collaborators including the Modernism Week Show House by Christopher Kennedy and the Stan Sackley tour and event produced by Thomboy Properties. A portion of proceeds from private events and tours go directly to the nonprofit organizations that partner with Modernism Week.

The City of Palm Springs is the Presenting Sponsor of Modernism Week. Upcoming events include the Modernism Week Fall Preview over the Columbus Day holiday

weekend Oct. 9-12, 2015, and the 11th annual Modernism Week will take place February 11-21, 2016.

RESEARCH ON MICE BY UC RIVERSIDE SCIENTISTS SHOWS GM SOYBEAN OIL IS AS UNHEALTHY AS CONVENTIONAL SOYBEAN OIL, WITH ONE BENEFIT: NO RESISTANCE TO INSULIN

Soybean oil accounts for more than 90 percent of all the seed oil production in the United States. Genetically modified (GM) soybean oil, made from seeds of GM soybean plants, was recently introduced into the food supply on the premise that it is healthier than conventional soybean oil.

But is that premise true?

Just barely, say scientists at the University of California, Riverside and their colleagues at UC Davis. The researchers compared the effects of both oils in experiments performed in the lab on mice. They found that the GM soybean oil is just as unhealthy as regular soybean oil in that it also induces obesity, diabetes and fatty liver. GM soybean oil does, however, have one advantage: it does not cause insulin resistance – the inability to efficiently use the hormone insulin.

"While genetic modification of crops can introduce new beneficial traits into existing crops, the resulting products need to be tested for long-term health effects before making assumptions about their impact on human health," said senior investigator Frances Sladek, a professor of cell biology and neuroscience at UC Riverside.

Study results will be presented tomorrow, March 6, at the Endocrine Society's 97th annual meeting, currently taking place in San Diego, Calif., by Poonamjot Deol, an assistant project scientist in the Department of Cell Biology and Neuroscience who is driving the project in the Sladek lab.

Naturally high in unsaturated fats, vegetable oils were once thought to be healthy, and were hydrogenated to increase their shelf life and temperature stability. The hydrogenation, however, generated trans fats – now widely recognized as being unhealthy.

Soybean oil, the most common vegetable oil used in the United States, contains about 55 percent linoleic acid, a polyunsaturated fat.

"Our previous results on mice showed that replacing some of the fat in a diet high in saturated fats from coconut oil with soybean oil – to achieve a level common in the American diet – causes significantly more weight gain, adiposity, diabetes and insulin resistance than in mice fed just the high-fat coconut oil diet," Sladek said.

To determine whether linoleic acid was responsible for the metabolic effects of soybean oil, the researchers designed a parallel diet in which regular soybean oil was replaced, on a per gram basis, with GM soybean oil. The GM soybean oil has a fatty acid composition (low linoleic acid) similar to that of olive oil. The GM plants were developed by DuPont to reduce trans fat production, increase soybean oil shelf life and create a generally healthier cooking oil.

"The GM soybean oil has 0 grams trans fat and more of the monounsaturated fats that are considered heart healthy," Deol said. "But it had not been tested for long term metabolic effects until our current study."

Deol and the rest of the research team found to their surprise that the parallel diet containing GM soybean oil induced weight gain and fatty liver essentially identical to that of a diet with regular soybean oil, with the exception that the mice remained insulin sensitive and had somewhat less adipose (fat) tissue.

"These results indicate that linoleic acid may contribute to insulin resistance and adiposity but that another as yet unidentified component of the soybean oil affects the liver and overall weight gain," Deol said.

In their experiments, the researchers gave four groups of mice different diets for 24 weeks. Each group was comprised of 12 mice. The control group received a low-fat diet (5 percent of daily calories from fat). The other groups received a diet with 40 percent of daily calories from fat, an amount common in the American diet. One diet was high in saturated fat from coconut oil, and one had 41 percent of the saturated fat replaced with regular soybean oil. The fourth group had 41 percent of the saturated fat replaced with the GM soybean oil. The body weights, food intake, glucose tolerance and insulin sensitivity of all the mice were tracked.

What the researchers found was that mice fed a diet with either of the soybean oils had worse fatty liver, glucose intolerance and obesity than the group that got all their fat from coconut oil. But the mice whose diet included the GM soybean oil had less fat tissue than the animals that ingested regular soybean oil. These mice weighed about 30 percent more than the controls that ate a low-fat diet, while the group on the diet containing regular soybean oil weighed 38 percent more than controls. The mice on the diet that was primarily coconut oil weighed only about 13 percent more than controls. Unlike the diet with regular soybean oil, the diet with the new GM soybean oil did not lead to insulin resistance.

"While the GM soybean oil may have fewer negative metabolic consequences than regular soybean oil, it may not necessarily be as healthy as olive oil, as has been assumed by its fatty acid composition, and it is certainly less healthy than coconut oil which is primarily saturated fat," Sladek said. "It is important to understand the metabolic effects and health impact of the GM soybean oil before it is widely adopted as a healthier alternative to regular soybean oil. It is equally important to understand the health effects of regular soybean oil, which is ubiquitous in the American diet and seems to be much more detrimental to metabolic health than saturated fat."

Sladek and Deol were joined in the research by Jane R. Evans, Antonia Rizo and Cynthia Perez at UCR; and Johannes Fahrmann, Dimitry Grapov, Jun Yang and Oliver Fiehn at UC Davis who performed extensive analysis on the liver and blood samples from these mice.

"To our knowledge this is the first in-depth analysis of the metabolic effects of GM soybean oil, and the first metabolomics analysis comparing soybean oil – regular and GM – to coconut oil," Deol said.

The research was supported by a UCR Collaborative Seed Grant as well as grants from the UCR Agricultural Experiment Station, and the UC Davis West Coast Metabolomics Center, funded by the National Institutes of Health. Deol was supported by a training grant from the National Institute of Environmental Health Sciences.

NEW PICKLEBALL COURTS OPEN AT FREEDOM PARK IN PALM DESERT

THERMAL AND OASIS ROADS TO BE RESURFACED

Three eastern Coachella Valley roadways with moderate damage and cracked surfaces will be resurfaced this spring.

The board of supervisors voted 5-0 to award the work to Matich Corporation of San Bernardino, which submitted the low bid of \$829,574. Matich Corporation has previously worked with the county on Mecca street improvements.

This project will improve segments of Avenue 66, Harrison Street and Tyler Street in the communities of Thermal and Oasis.

"These roads are in need of repair and will be getting smooth surfaces and safety improvements," said Supervisor John J. Benoit. "This is an investment in the eastern Coachella Valley to significantly improve these roads and extend their service life, enhance safety and keep agriculture and industry moving."

A 0.95 mile segment of Avenue 66 will be paved from Van Buren Street to Harrison Street. Harrison Street will be paved from 0.38 mile northwest of Pierce Street to 0.21 mile south of Pierce Street. Tyler Street will be paved from 0.46 north of Avenue 66 to 1 mile north of Avenue 66.

The roads are used by local farms and businesses, and are among approximately 2,100 miles maintained by the Riverside County Transportation Department.



The project will be funded by local transportation funds. Construction is expected to be completed by June.

IN CALIFORNIA 1,412,200 CONSUMERS ARE ENROLLED IN 2015 HEALTH INSURANCE MARKETPLACE COVERAGE

In California, 1,412,200 consumers selected or were automatically re-enrolled in quality, affordable health insurance coverage through the Health Insurance Marketplace as of Feb. 22, according to a report released today by the U.S. Department of Health and Human Services. Of the consumers with a Marketplace plan selection, 90 percent (1,271,239 people) qualified for financial assistance to help with the cost of monthly premiums.

In California, 460,531 consumers under the age of 35 are signed up for Marketplace coverage (33 percent of all plan selections). And 387,297 consumers 18 to 34 years of age (28 percent of all plan selections) are signed up for Marketplace coverage.

"The figures released today tell a story of health coverage consumers rely on for financial and health security," said Secretary Sylvia M. Burwell. "In California 1,271,239 Marketplace consumers qualified for tax credits to make their coverage affordable and accessible. People who come to the Marketplace for coverage are actively engaged and shopping for the product that's best for them and their families. The Affordable Care Act is working and we're grateful to the volunteers, assisters, navigators, local officials, Members of Congress and many national organizations who joined this effort across the country."

Nationwide, nearly 11.7 million consumers selected a plan or were automatically enrolled in Marketplace coverage. Of those, 8.84 million (76 percent) were in states using the HealthCare.gov platform and 2.85 million (24 percent) were in the 14 states (including California and Washington, D.C.) using their own Marketplace platforms. Nearly 7.7 million individuals with a plan selection in the states using HealthCare.gov qualified for an average tax credit of \$263 per month and more than half (55 percent) paid \$100 or less per month after tax credits.

Nationwide, more than 4.1 million consumers under the age of 35 are signed up for Marketplace coverage (35 percent of all plan selections compared to 34 percent of plan selections at the end of 2014 Open Enrollment). And nearly 3.3 million consumers 18 to 34 years of age are signed up for Marketplace coverage. As in 2014 that's 28 percent of all plan selections.

Today's report includes data for individuals who selected or were automatically reenrolled in coverage through Feb. 21 for 12 states and Washington, D.C. using their own Marketplace platforms and through Feb. 22 for the 37 states using the HealthCare.gov

platform (including Oregon and Nevada), as well as California which is a State based Marketplace.

Today's report does not include information on effectuated enrollment. To have their coverage effectuated, consumers need to pay their first month's health plan premium.

Open Enrollment in the Marketplace ended on Feb. 15. Consumers should visit HealthCare.gov to see if they qualify for a Special Enrollment Period because of a life change like marriage, having a baby or losing other coverage. Enrollment in Medicaid and the Children's Health Insurance Program is also open year-round.

RIVERSIDE COUNTY OFFICIAL NAMED OUTSTANDING CIVIL ENGINEER IN CALIFORNIA'S PUBLIC SECTOR



The California region of an international engineering society has named Riverside County's second-ranking administrator as the 2014 outstanding civil engineer in California's public sector.

George A. Johnson began his career with Riverside County in 1991 as a civil engineer in the Transportation Department. He later headed the county Transportation Department and directed all county transportation and land-use functions before taking over the No. 2 spot in the county Executive Office in May 2012, chosen by Executive Officer Jay Orr.

His nomination for the American Society of Civil Engineers' (ASCE) award notes that Johnson's enthusiasm and collaborative style in land-use planning, transportation infrastructure and habitat protection have helped the county maintain a quality of life that residents

expect and deserve.

"George's engineering skills and common sense help him deal with people on a personal level in order to solve problems and be innovative," said John Rogers, 2013-14 vice president of society's branch in San Bernardino and Riverside counties. "Most importantly, his efforts help advance projects that are always geared toward improving the community."

Through the years, Johnson's work has focused on a multitude of projects. He oversaw construction of freeway interchanges and the replacement of aging bridges throughout the county. He was the lead county staff member in creating the Temecula Wine Country Community Plan, which serves as a guide for developing Temecula Wine Country into a world-class wine region. He helped develop an education building at the Riverside County Medical Center and implement a county general-plan overhaul that established new transportation corridors and a created a nationally recognized multispecies habitat conservation plan. He now helps oversee expansion of the county's jail system and master plan, which includes construction of a \$300 million, 1,600-bed jail in Indio.

Johnson received the award Friday (March 6) in San Diego at a ceremony the society held in conjunction with a statewide infrastructure symposium on water-supply and transportation issues. He received the award at the local and regional level before being honored statewide. A devastating blow for our creative economy

By The Public Record Editorial Board

The news of direct response marketer Guthy-Renker closing its Palm Desert office is yet another devastating blow to the Coachella Valley's effort to attract and retain businesses that provide employment for college educated workers with year-around middle class wages.

More than 80 percent of our local businesses depend on trade from consumers who make middle class wages or better, but in a manner similar to our dependence on foreign oil to sustain our energy needs, the Coachella Valley's economy is at risk for our dependence on imported middle class consumers.

As the tourist industry achieves greater success each year, the resulting economic downturn during the summer months gets deeper and more severe.

In 2011 economic leaders commissioned "The Creative Economy Baseline Study" which showed great potential to expand employment into high skill, high wage creative occupations.

Meanwhile, local businesses and their trade associations encourage our high school graduates to pursue a college degree through the generous scholarships they award each year.

Yet, the valley's economic development efforts continue to look in the rear view mirror; focusing on low skilled, low wage jobs that support a seasonal, service industry economy. More than a third of our residents earn incomes below the poverty level.

It is true that we have made some progress in growing the healthcare industry, which tends to pay better wages — but even in this sector; there are still a lot of part time and minimum wage jobs.

Nearly every high school in the valley has some kind of media-related career academy but graduates will find few businesses that are looking for those skills here. While the Palm Desert office of Guthy-Renker does not produce the infomercials the company

is famous for, there is no reason why that business could not be cultivated here. If the firm can persuade 55 people to move from the desert to Los Angeles, why couldn't they do the reverse?

We have a lot offer a skilled workforce over Los Angeles with its sky-high housing prices and gridlocked freeways, just to name two benefits. All you need to produce an infomercial is a soundstage and a crew. Clearly there are more of those in LA, but whether there are 100 or 10 possibilities, if you only need one crew what difference does it make?

Our economic leaders should be making every effort to retain and expand Gunthy-Renker here. There is no reason why the Coachella Valley shouldn't be a mecca for corporate headquarters for creative firms like this.

Despite the promising results of the 2011 Creative Economy study, CVEP abandoned its ArtOasis partnership to the Greater Palm Springs CVB where the effort has withered to merely promoting Community Theater and cultural tourism — creative sectors that offer few full-time middle class jobs.

It is imperative that we grow our own middle class of year-round residents, so we need to court firms like Gunty-Renker with the same zeal that we pursue big box retailers and hotel chains.
