**HARC Receives Research Grant from The Community Foundation  
to Help Underwrite 2010 *Community Health Monitor***

(PALM DESERT, CA) – Seeking deeper insight into the health needs of its local population, The Community Foundation Serving Riverside and San Bernardino Counties has awarded the Health Assessment Resource Center (HARC) a \$10,000 grant. Funding will be earmarked for HARC’s 2010 *Community Health Monitor*, the sequel to its 2007 groundbreaking study on the region’s collective health and wellness.

The triennial survey gathers data from more than 3,000 households throughout Eastern Riverside County. Respondents field questions related to their health status, behavioral risks, quality of life issues, access, and utilization of services. For the inaugural effort, a total of 172 questions comprised the adult survey and 136 were focused on children’s health issues.

The HARC data delivers healthcare providers, cities, government agencies, and private interests a clearer snapshot of public health in eastern Riverside County. HARC data is used to facilitate decision-making on a range of issues, including program development, access to care, funding, utilization, and more. In addition to furnishing the data, the nonprofit research organization also conducts a series of multi-modal workshops with local organizations to show them how the information can enhance organizational learning, advocacy and effectiveness of community outreach.

Funding for The Community Foundation grant comes from the nonprofit's Community Impact Fund. It will cover work performed between now and April 30, 2010.

“Securing The Community Foundation’s financial support sends a strong signal to the broader nonprofit community about the importance and need for statistically reliable regional healthcare data,” said HARC Board President Glen Grayman, MD. “We are thrilled to have them on board.”

The Community Foundation grant follows a \$600,000, three-year commitment to HARC from the Desert Healthcare District. That funding is also earmarked for the upcoming *Community Health Monitor* initiative.
