Khanna, M.D., Board Certified Interventional Cardiologist, was the first physician in Riverside County (sixth nationwide) to utilize the Diamondback 360® Coronary Orbital Atherectomy System—an innovative tool for treatment of severely calcified coronary arteries—after its recent Food and Drug Administration (FDA) approval.

In healthy arteries, smooth inner walls allow blood to flow easily. In people with CAD, the plaque buildup causes atherosclerosis, in which arteries harden and narrow, reducing blood flow. Arterial plaque can reduce blood flow or, in some instances, block it altogether causing heart attack or stroke. A person is at higher risk of CAD if they have abnormal cholesterol levels, high blood pressure, diabetes, smoking, or family history of early heart disease. According to the Centers for Disease Control and Prevention, about half of all Americans have at least one of the three key risk factors of high blood pressure, high cholesterol or smoking.

Eisenhower Medical Center was the site of one of the clinical trials that led to the FDA's recent approval of the Diamondback 360 device that removes calcified plaque from coronary arteries with minimal effect to the surrounding healthy tissue. With its diamond tip, the Diamondback 360 sands arterial plaque down to micro particulates smaller than red blood cells, which are then absorbed and removed by the body. The arteries are then ready for placement of one or multiple stents to keep the artery open and free from additional plaque buildup

Dr Khanna's experience with the Diamondback 360 dates back several years. In 2010, Khanna was the first physician in the United States to use the Diamondback 360 technology in the FDA-approved Orbit II clinical trial. "I believe that the Diamondback 360 is an essential advancement in treating patients with this type of disease," says Khanna. "This easy-to-use tool proved, through the Orbit I and II trials, to be safe and effective in treating calcified lesions in order to facilitate stent placement."

HARC TO RELEASE RESULTS OF TRIENNIAL COMMUNITY HEALTH ASSESSMENT FEBRUARY 13

Armed with the most recent, comprehensive data on the collective health of Coachella Valley, officials at the Health Assessment Resource Center (HARC) will unveil the 2013 Community Health Monitor Thursday, Feb. 13, beginning at 8 a.m. The triennial event, the third of its kind, will take place at the Indian Wells Theatre on the Palm Desert campus of California State University San Bernardino. There is no admission fee and the public is invited to attend.

HARC researchers interviewed more than 2,400 people in the exhaustive survey, which assessed both adults and children Questions focused on issues such as access to healthcare, behavioral risk factors, current health challenges, gaps in services, as well as demographics. The fieldwork phase concluded last summer, followed by an extensive period of data tabulation, review and analysis.

Ihe master of eeremonies at the event will be Dr G Richard Olds, Founding Dean of the University of California, Riverside, School of Medicine and HARC Board Member.
