Anthem Blue Cross rate increase on small group policies called "excessive and unreasonable"

STAFF REPORTS

Insurance Commissioner Dave Jones announced that an average 9.8 percent premium increase Anthem Blue Cross is imposing on 120,000 members in small group health insurance policies is unreasonable. This latest increase is the fourth consecutive rate increase by Anthem on small employers that the Department of Insurance found excessive and unreasonable.

This 4th quarter rate increase for Anthem's small group policyholders imposes an average rate increase of 9.8 percent, while over the last 24 months Anthem has raised rates on members in these small group policies an average of 24.9 percent.

"Anthem Blue Cross is once again imposing an unreasonable rate increase on its small employer members, while continuing to make excessive profits of over 20 percent," said Insurance Commissioner Dave Jones. "Small employers continue to



HARC study shows unemployment equally distributed across education levels

TARC, the valley's Health Assess-**■** Iment Resource Center, recently released a data brief on Health & Unemployment. It's most astonishing finding is that unemployment is almost equally distributed across all education levels, each group accounting for about 25 percent: less than high school, high school or GED, some college and all levels of college degrees. Conventional wisdom says that as the level of educational attainment rises. the incidence of unemployment declines. Eileen Packer, HARC's CEO, attributes the high unemployment among highly educated workers to the likelihood of older individuals being retired, but other experts speculated the valley's scarcity of jobs requiring a college degree could be a contributing factor.

The survey shows nearly 10 percent of the adult population in the Coachella Valley is unemployed. The unemployment rate jumped sharply during the Great Recession—from just under 5 percent in 2007 to a peak of over 10 percent in 2010. So far, the recovery has been slow and many of the newly created jobs are part-



time, temporary positions that do not offer health benefits.

Most of the unemployed (92 percent) are under age 65. The age groups with the highest unemployment rates are those 25 to 34 (36.6 percent) and 45 to 54 (19.7 percent). The smallest groups: 75 and up (2.1 percent) and 18 to 24 (4.8 percent).

While the majority of unemployed

persons have no health insurance, a surprising 43 percent do. Packer said those with insurance probably are on Cobra plans or are able to take advantage of a partner's healthcare program. Others may qualify for government health programs.

Meanwhile, 20 percent of employed individuals still didn't have health coverage at the time of the survey, which was

conducted before the rollout of the Affordable Healthcare Act. Packer speculated this should reduce the number of employed and unemployed persons without insurance, but it's too early to tell. "Hopefully, we're going to see a downward trend (when we do the survey again) in 2016. I think that that major shift is going to make it more affordable for people."

The unemployed are, on average, about 75 percent less likely to have health coverage for dental, vision and mental health services. Even when they do have coverage to see a doctor for a diagnosis, they are less likely to obtain treatment due to the cost of dental work, eyeglasses and prescription drugs.

This isn't to say that employed persons with health coverage are necessarily more motivated to seek medical care. Forty-one percent of employed workers had not seen a dentist in over 12 months compared to 52 percent of the unemployed. Employed persons were twice as likely to have seen a doctor, however.

Over half of unemployed survey respondents admitted to "binge drinking" one or more days in the past month compared to 34 percent among the employed. The unemployed were twice as likely to be

Among the biggest health threats to the unemployed—and individuals who don't see a primary care physician on a regular basis—is undiagnosed diabetes. This puts those individuals at high risk for complications. About 13 percent of unemployed adults have been diagnosed with the disease compared to less than 5 percent of employed persons. Over 60 percent of unemployed diabetics have never had their blood checked, presumably because they lack the resources to pay for the tests.

The report also looked at "food insecurity," indicating that nearly 40 percent of unemployed adults needed food assistance in the past year.

This special brief was funded by a grant from Desert Healthcare District. The data was derived from the 2013 Community Health Monitor study. The report cautions that it defines "unemployed" slightly differently than the U.S. Department of Labor's definition.

Packer said she anticipates a grant from another government entity to fund a special report on mental health in the near future. "We do not want our data to sit on a shelf. We want people to look at it, inquire about it, and to discuss what the results are," said Packer.

These reports and other studies are available without charge on the HARC website at harcdata.org.

Medi-Cal Expansion

In addition to the launch of the Affordable Care Act, California expanded its Medi-Cal program in January, providing free or low-cost health coverage for a few million low income Californians under age 65. To quality, individuals must earn less that \$15,856.

Core services include doctor visits, hospital care, emergency services, nursing home care for individuals age 21 or older as well as prescription drugs. An array of mental health and substance abuse services were also added in January and Medi-Cal began providing a dental fee-for-service feature in May.

The Covered California website will automatically direct individuals most likely to qualify for Medi-Cal benefits to those options.

Insurance Marketplace

For those who earn too much to qualify for Medi-Cal, Covered California offers subsidized insurance programs. An individual earning California's \$9 per hour minimum wage, working full time, would earn \$18,720 per year. A basic Blue Shield plan can be purchased for a monthly premium of only \$24.12, with a \$183 per month subsidy. This

may sound like a bargain until you read the fine print: there is no coverage for a routine primary care visit until the insured first pays out a \$4,500 annual deductible. Then the insurance will pay only 40 percent of the office visit. The same is true for most of the other benefits except for preventative care, screening and immunization, which are provided with no copay required.

In order to qualify for primary care visits with a \$15 copay and no annual deductible requirement, the policyholder would have to pay get a "Silver" plan, starting at \$54.69 per month. That's about 5 percent of net income for our minimum wage worker.

struggle in this recovering economy and only dream of having the level of profits that Anthem and other health insurers have as they continue to increase their rates each year. Unfortunately, California does not have the authority to reject excessive health insurance rates, unlike 35 other states which have this authority."

The Department of Insurance's finding that Anthem's rate increase is unreasonable is based on Anthem's excessive return on equity or profits, its excessive pre-tax pricing margin, its unjustified high-pricing trend of 8.6 percent, which includes a prescription drug trend of 21.4 percent, and its failure to adjust the rate for the better health status of its remaining members.

Also of note, last year Anthem shifted \$75.5 million of income to what they call a premium deficiency reserve. This accounting maneuver was unwarranted and unjustified and decreased Anthem's reported net income for 2013 and masked the fact that the company's profit was over 20 percent. In five out of the last six years Anthem has attained a greater than 20 percent profit.

"For the fourth consecutive time, over two years, Anthem has decided to implement an excessive and unjustified rate increase on small employers. This pattern and practice of excessive premium increases has a cumulative impact on the bottom line for California small businesses and yet, we are powerless to stop it. Anthem's refusal to lower this excessive rate increase means that small businesses will be charged \$33 million in excessive premium and their only choices are to drop coverage or shop for other coverage, which often means a change in benefits or medical providers for their employees. California's small employers deserve better than excessive rate increase after excessive rate increase," added Jones.

The department's conclusion that Anthem's rate increase is excessive and unreasonable is based on data provided by the company and a comprehensive analysis by the department's actuaries. The department's health actuaries reviewed all aspects of the rate filings, including past claims history, utilization trends, medical and administrative costs, return on equity, and many other elements of the rate, and determined it was unreasonable.

The commissioner's authority is limited to reviewing rate filings, with no authority to stop excessive health insurance rates from being imposed on policyholders. While state law requires the commissioner to determine if rates are excessive or unreasonable, neither state nor federal law makes the commissioner's determination binding on the health insurers.

Hard to argue with many of the sentiments that Jerry Brown expressed in his interview published over the weekend by the Los Angeles Times about his vision for a fourth term.

He talked about ending the "gold rush for new programs and spending" that legislators would seek giving an uptick in revenues. This page has written about that many times – take care of the spending side even if we need a spending limit to enforce controls. Brown says he wants to use common sense and the power of his office to control spending.

Brown spoke of the tens of thousands of laws put on Californians in the last half-century. Referring to too many building restrictions "like Gulliver being tied by these Lilliputians, with more and more little strings and ropes." Many on this site have written about pulling back on regulations that hamper a growing economy. Limitations should be put on the number of laws passed annually. Some time and thought should be given by the legislature to reducing many laws on the books. As I have mentioned before, it is unfortunate on one level that the term often used for a legislator is lawmaker.

Additionally, Gov. Brown spoke of more local control and restricting the reach of state bureaucracy – both good ideas.

He also said firmly: Hands off Proposition 13. "Prop. 13 is a sacred doctrine

that should never be questioned," he is quoted in the Times article. "That doesn't mean that we can't look at our tax code in various ways."

My column a few weeks ago supported Proposition 2 on this year's ballot as a spending control and budget insurance policy while at the same time promoting tax reform.

Of course, important issues were not mentioned in the article that would have been nice to hear about. The burden to state and local governments from pension and health care costs for government employees for example.

Then, there was the enigmatic expression in which Brown said he was saving some of his campaign war chest millions

for potential ballot measures in his second term without revealing what those ballot measures might be.

Enigmatic and full of surprises is a good depiction of Jerry Brown.

Focusing on the issues reported in the Times article, an agenda of reducing regulations, fewer laws and tax reform would boost the economy. The big question, if Brown gets elected and holds tight to such a program, can he accomplish those goals with the majority in the legislature?

For the time being, it seems that on a number of issues, at least, I'm traveling on the same train as Gov. Brown–well not THAT train!

MORE PEOPLE, MORE JOBS, HIGHER HOME PRICES

A new forecast for the U.S., California, and Inland Empire economies finds that the recovery at the national, state, and regional level is continuing despite the weakening global situation.

The forecast, authored by Beacon Economics and released in partnership with the University of California, Riverside's School of Business Administration as part of the 2014 Riverside/San Bernardino Economic Forecast Conference, reports that unlike the U.S.-led recession of 2008, this time, the U.S. economy will be an important source of strength globally as the world works to get back onto a growth trajectory.

Moreover, the new forecast does not find anything on the international front that could seriously derail the nation's economy, projecting it to expand at an annual pace of modestly over 3 percent in 2015, and improving even further the following year. "Nearly every part of the U.S. economy is showing signs of slow but steady improvement," says Beacon Economics' founding partner and one of the forecast's lead authors Christopher Thornberg. "The only thing acting as a drain currently is the export sector, due to the global slowdown, but there is actually enough momentum in the U.S. economy to push us past these broader international troubles."

Virtually every economic indicator in California's enormous economy has also continued on a growth path and events at the international level have not significantly af-

fected the Inland Empire's economy, according to the analysis. In fact, the local logistics sector is expected to expand in the near future with widespread developments of warehouses and distribution centers appearing across the inland region. Statewide, growth is forecast for employment (2.5 percent annual growth by 2016), home sales (up by double-digit percentages in 2015), residential construction (190,000 new units over the next two years), and most other leading indicators.

One of the structural problems identified in the analysis, however, is that while California continues to have a relatively educated population base, over the past decade or so that advantage has slowly been reduced as other states have raised their levels of educational attainment faster. The analysis points to the importance of maintaining an educated workforce in California, where highly skilled tech sectors drive so much of the state's economic growth.

Yunzeng Wang, dean of the School of Business Administration at UC Riverside, says there has never been a more critical time to focus on building and educating a workforce that is prepared to drive California's economy forward. "This state is home to some of the greatest innovators and strongest companies in the world. But from the data, we can see we won't have the workforce we need to maintain our leading position in the future," says Wang. "As educators, we can't diminish or veer from the critical role we play in teaching and building leaders who have the skill sets and training needed to



become successful – for themselves and for their communities."

This is the fifth year the School of Business Administration, the only research-based business school in Inland Southern California, has partnered with Beacon Economics to release an economic forecast. The forecast event will include a panel discussion of entrepreneurship and company building in the Inland Empire.

Key U.S., California and Riverside/San Bernardino findings from the forecast include:

Riverside/San Bernardino counties: Compared to the last economic recovery, from 2001 to 2005, the current recovery has lacked support from the construction (added just 0.1 percentage points to gross metropolitan product growth from 2009-2013) and retail trade (added 0.4 percentage points to gross metropolitan product growth from 2009-2013) industries. However, both industries are starting to heat up, a good omen for the economy at large.

California: Home prices will continue to grow in California over the next two years, although growth will cool to the 4 percent to 6 percent range. The recent, rapid home price expansion in the state is not sustainable in the long run and it is a healthy sign to see price increases slowing to a level more consistent with income growth.

United States: While the U.S economy is doing relatively well and expected to be a leader in the global recovery, the nation continues to face some major imbalances that keep the economy from growing even faster. These include construction investments, the still too-large-to-be-sustainable trade deficit, and public direct spending – which is 13 percent of the economy today, down from 15.5 percent in 2000. Additionally, the potential for inflation and rising interest rates have raised concerns although the forecast is relatively benign on both and finds little that will change the current path of Federal Reserve policy or price growth. The outlook has the Fed's rate up to possibly 2 percent by the end of 2015. Long-term rates will respond, but only modestly.

PALM DESERT RESIDENTS CAN GET MONEY BACK FOR PET ADOPTIONS, VACCINATIONS, AND MORE

The City of Palm Desert cares about pets and their owners and now offers reimbursements to residents who vaccinate and spay or neuter their pets as well as money back to residents who adopt a new cat or dog from the City's animal shelter.

Palm Desert residents, with proof of residency, are eligible to receive reimbursements for spay and neutering procedures and routine vaccinations conducted at all Coachella Valley nonprofit animal organizations and Palm Desert for-profit animal clinics.

Reimbursements are available for up to four animals per household per year at a rate of \$25 for routine vaccinations and \$50 per spay or neuter on a first-come, first-served basis based on available funds.

The City also continues to offer its adoption reimbursement program. Palm Desert residents who provide proof to the City's Code Compliance Department that they have adopted a cat or dog from the Coachella Valley Animal Campus, 72050 Pet Land Place, in Thousand Palms, can receive reimbursement from the City for their adoption fees, which range in cost from \$55 to \$113.

SOUTHERN CALIFORNIA PROPERTY VALUES INCREASE 6 PERCENT

Following a statewide trend, Riverside County's overall property values increased 8.2 percent for 2014-15 with \$230.328 billion in assessed value, helping Southern California see an overall increase of 6.0 percent, announced California State Board of Equalization vice chair Michelle Steel. Orange, San Bernardino, and San Diego counties also experience healthy growth rates of 6.3, 6.1, and 5.7 percent respectively.

Statewide, the total value of state- and county-assessed property increased for the fourth straight year. For 2014-15, values rose to \$4.918 trillion, an increase of \$282.2 billion (6.1 percent) from the previous year.

"I'm pleased to see property values rise once again," vice chair Steel said. "Hopefully this trend — along with economic growth — will continue in our region and throughout the state."

The value of county-assessed property increased by \$279.7 billion (6.2 percent) to \$4.825 trillion. The value of state-assessed property, mainly privately owned public utilities and railroads, totaled \$93.3 billion, an increase of \$2.5 billion (2.7 percent).

In all, 55 out of 58 counties posted year-over-year increases in assessed value, with most of those increases being more than 2.0 percent. Three counties experienced year-over-year declines in value, but none were greater than 1.0 percent. Thirty-two counties grew in excess of 5.0 percent.

Year-over-year percentage changes ranged from a high of 11.4 percent in Stanislaus County to a decline of 1.0 percent in Sierra County. Growth in Stanislaus County, and the Central Valley (6.5 percent) as a whole, was largely due to the continued recovery in the real estate market.

In the Greater Sacramento Area, assessed values rose 6.3 percent, fueled by another year of real estate market recovery.

The assessed values in California's 15 coastal counties — which account for more than 60 percent of total assessed valuation — gained 5.7 percent, while values in the 43 inland counties rose 6.6 percent. San Francisco Bay Area values increased 6.5 percent.

Of the counties with rolls exceeding \$100 billion, all 12 posted higher assessed values. Those counties include: Contra Costa (8.9 percent), Riverside (8.2 percent), Santa Clara (6.8 percent), Sacramento (6.4 percent), Orange (6.3 percent), San Bernardino (6.1 percent), Alameda (5.9 percent), San Diego (5.7 percent), Ventura (5.6 percent), and San Francisco and San Mateo (5.4 percent). Los Angeles County, with the largest assessment roll at \$1.216 trillion, increased by 5.4 percent, up \$62.5 billion over 2013-14.

AICPA MODERNIZES NON-AUDIT STANDARDS FOR ACCOUNTANTS IN PUBLIC PRACTICE

The American Institute of CPAs (AICPA) is poised to introduce Statement on Standards for Accounting and Review Services No. 21 (SSARS No. 21), which is one of the most significant revisions in non-audit standards in the last 35 years.

SSARS No. 21 represents the AICPA's Accounting and Review Services Commit-

tee's (ARSC) efforts to clarify and revise the standards for members in public practice who perform reviews, compilations, and engagements to prepare financial statements. Approved by ARSC in August, it creates a bright line between accounting (preparation) services and reporting (compilation or review) services and is a better fit for the current electronic and cloud-based practice environment.

The basic standard for accountants who have prepared and submitted financial statements to their clients was issued as SSARS No. 1 in 1978, said Michael L. Brand, chair of ARSC and a partner with the firm of Johnson, Feigley, Newton & Brand in Athens, Alabama. "Back then, accountants prepared paper financial statements, bound them with their firm's covers and mailed them or handed them to their clients. It made sense, for many years that because these were submitted by the CPA, the CPA should, at a minimum, issue a compilation report on those financial statements," Brand explained. "However, in today's electronic environment, especially cloud applications where the client and CPA are working on the accounting together and sometimes in real time, it's impossible to segregate who prepared the financial statements, let alone whether the CPA submitted financial statements. Section 80 of SSARS No. 21 totally eliminates the need for such arbitrary and irrelevant decisions by making the compilation literature apply when the accountant is engaged to perform a compilation service."

In addition, to help firms that are asked by their smaller clients to prepare financial statements when that client does not need a compilation or review report, SSARS No. 21 includes a new preparation standard. Further, Section 70 does not require an accountant's name or report to be associated with the preparation of the financial statements, but it also does not prohibit a CPA from doing so, according to AICPA Senior Technical Manager Michael Glynn. "Therefore, to ensure that users are not misled by thinking that an accountant is providing any assurance on the financial statements, the standard requires a legend on each page of the financial statements indicating, at a minimum that 'no assurance is provided' on the financial statements."

The newly-revised standards are effective for engagements on financial statements for periods ending on or after Dec. 15, 2015. Early implementation will be permitted.

The name was taken from the women's group that was supporting the club, the Palm Springs Pathfinders. The first summer 60 boys attended, sleeping in tents and dining in an army field tent from WW II.

AICPA URGES EEOC TO STOP INVESTIGATIONS OF ACCOUNTING PARTNERSHIP RETIREMENT PRACTICES

In a letter to the Equal Employment Opportunity Commission (EEOC), the American Institute of CPAs (AICPA) has asked commissioners to reject staff appeals to investigate and litigate against accounting firms regarding partner retirement provisions, saying the classification of partners as employees would be very disruptive to the accounting profession and its business practices.

In the Oct. 20 letter, AICPA President and CEO Barry Melancon, CPA, CGMA,

explained, "We understand that the EEOC staff is currently investigating and considering litigation against accounting firms regarding the partner retirement provisions in their partnership agreements. You will recall that less than 18 months ago, the EEOC staff completed a similar investigation of another large accounting firm. As the EEOC General Counsel's office wrote in its July 25, 2013 informal comment letter, control – meaning whether partners control their own work and own and control a portion of their firms – is the touchstone to the determination that they are indeed partners rather than employees. Because of the nature of the accounting profession, we believe that the partners of our member firms – like the firms the staff is investigating – do have such control and that the EEOC should not bring actions against these firms."

The AICPA is encouraging Commissioners to exercise their authority to reject any attempt by the General Counsel to file litigation with respect to accounting partnership retirement practices Further, the Institute is requesting that Commissioners direct the EEOC staff and General Counsel to "stop these unwarranted and unnecessary investigations of accounting firm partnerships and utilize the Commission's resources in a more productive manner that will address actual discrimination practices."

The full text of the letter, which copied members of the Senate Committee on Health Education, Labor and Pensions and House Committee on Education and the Workforce, follows.

CANADIAN SNOWBIRDS ENCOURAGED TO BUY A FLORIDA HOME

As Canadian snowbirds prepare to head south, the Annual Snowbird outlook from BMO Bank of Montreal is telling Canadians that "U.S. housing affordability remains healthy, and prices are expected to increase in Florida, Arizona and other popular areas."

The bank offers only two warnings to Canadians considering a southern move: The border crossing rules are more strict, and a strengthening U.S. dollar could make purchases in Florida and elsewhere more expensive.

"Overall, U.S. house prices have soared 20 percent in the past two years, but are only about half way back to their peak in 2006," and "Traditional destinations for Canadian Snowbirds remain affordable," the bank says. "Compared to their peaks, prices in Tampa are down 34 percent, Phoenix down 30 percent, Las Vegas off 43 percent, and Miami down a whopping 52 percent."

"Now, with the American economy and employment gaining strength, home sales should gather some momentum," advises Sal Guatieri, senior economist, BMO Capital Markets. "We expect prices to rise over time alongside growing family incomes."

Guatieri also says BMO expects "capital gains appreciation for Canadians who purchase U.S. property."

COVERED CALIFORNIA ANNOUNCES OPEN ENROLLMENT STARTING NOV. 15

Covered California announced it has begun the renewal process for 1.12 million individuals who enrolled in plans in the exchange last year and unveiled substantial new improvements to facilitate enrollment in coverage for 2015.

"Last year, we succeeded in signing up millions of Californians in health coverage through Covered California and Medi-Cal," Covered California Executive Director Peter V. Lee said. "We learned a great deal in the process, and in this second open enrollment we are building on those lessons using effective and concrete changes."

The first wave of renewal notices was sent to consumers Wednesday. Consumers who complete the renewal process will hear from their insurance plans in December. Their selected health plan will send a statement reflecting coverage starting Jan. 1, 2015. Consumers who take no action will be renewed into their existing plan.

Individuals who have health coverage through Medi-Cal renew their coverage throughout the year, on a rolling monthly schedule. Medi-Cal will contact them directly if they need to take action. Unless they are contacted by Medi-Cal, these individuals do not need to go to the Covered California website to renew or apply.

Covered California also provided updated enrollment numbers for 2014 Thursday. Of the Californians who selected a plan during the initial open enrollment, 1,140,000 (or 81 percent) had their coverage take effect by paying their first month's premium. Today, a total of 1.12 million individuals have effectuated coverage and will be part of the renewal process. Covered California expects this number to increase as special enrollment continues and as recent enrollees effectuate their coverage, with about 1.3 million Californians participating in the renewal process through the end of the year.

"This is our very first experience with renewal, and we will learn things during this process just as we learned a great deal about open enrollment during 2013-2014. We do believe many significant improvements have been made that will assist our consumers during both renewal and open enrollment this year," Lee said.

In the meantime, Covered California continues to gear up for open enrollment, which will begin Nov. 15 and continue through Feb. 15. Open enrollment is the next opportunity for all Californians to benefit from new insurance rules, including the requirement that insurance be offered regardless of health status. In addition, this is the window of time when Californians can buy subsidized coverage starting in 2015.

"We know this open-enrollment period will be more challenging in some ways. Consumers will only have three months to enroll, compared with the six months they had last time. This is complicated by our knowledge that many who are uninsured have adapted to a culture of coping and have become accustomed to living without health insurance," Lee said.

With less than one month before open enrollment begins, consumers can begin the process of shopping for 2015 coverage. They can find out if they are eligible for financial assistance and find out how much a health plan will cost them, by using Covered California's Shop and Compare Tool on CoveredCA.com.
