About HARC

HARC is a 501(c)3 nonprofit research and evaluation organization located in Palm Desert. Founded in 2006, HARC was intended to provide local data that could be used by leaders to tell the unique story of health, well-being, and quality of life in the Coachella Valley region of Southern California.

HARC began this work by providing a population health survey of the Coachella Valley community. Guided by over 30 local leaders as well as expert consultants, it was determined that this survey would be conducted via random-digit-dial telephone interviews in English and Spanish, repeated every three years to provide on-going trends. The content of the survey is community-driven, and covers topics such as health care access, utilization, health behaviors, major disease, mental health, and more. The first survey was conducted in 2007, and results were provided to the community in early 2008. To date, the survey has been conducted six times (2007, 2010, 2013, 2016, 2019, 2022). Results are provided back to the community in the form of a written Executive Report, infographics, and special reports and data briefs on a variety of focused health issues.

The data provided by the Coachella Valley Community Health Survey is used by nonprofits, hospitals, higher education, K-12 education, governmental agencies, and media organizations, among others. These organizations use the data to apply for funding, create presentations/lectures, prioritizing health needs, developing programs to address those needs, writing articles, designing and conducting trainings, and making/changing policy.

In 2009, HARC branched out from the Coachella Valley Community Health Survey and began to offer customized research and evaluation services for other organizations. Through these services, HARC shares the advanced expertise of their researchers with organizations who otherwise would go without reliable data. These services include program evaluation, needs assessments, data analysis, client satisfaction surveys, workplace wellness services, and much more. Clients come from across California, with a strong emphasis on the Inland Empire.

HARC's expertise lies in the social determinants of health; that is, the idea that where you live, work, learn, and play has a strong impact on your well-being and quality of life. The social determinants of health encompass things like economic security, education, safety, community cohesion, neighborhoods and the built environment, and of course, healthcare.

HARC is dedicated to working collaboratively with partners to improve lives in communities. We believe our expertise in data and information is a critical piece to lifting up the quality of life in communities.

Executive Introduction



Dear Reader,

During Fiscal Year 2022-2023, we accomplished some major milestones, as you'll see in this report. We were able to complete our sixth triennial Coachella Valley Health Survey and provide those results back to the community at no charge in February 2023. We look forward to working with partners to leverage this data into positive change for our Coachella Valley.

Simultaneously, we worked on 27 client projects to help improve health, wellness, and quality of life in our communities. We worked on community health needs

assessments, evaluations, client satisfaction surveys, COVID-19 studies, and much more. Some landmark projects this year included a second county-wide needs assessment related to COVID-19 in partnership with Riverside University Health System – Public Health, as well as a new project on gun violence reduction for the County of San Diego, among others.

We also were a major partner in the Ark of Safety movement, led by Building Resilient Communities, which strives to improve resiliency in our Inland Empire. I was lucky enough to be the Master of Ceremonies (MC) at three Ark of Safety events in September 2022, January 2023, and June 2023, as well as the author on the follow-up reports.

We were able to accomplish these goals because we have an amazingly talented staff that continues to grow in strength, size, and tenure. During this fiscal year, our Research and Evaluation Assistant, Amairani Ramos, left for the next phase of her life (graduate school—we wish her the best!) and was replaced by Bernardo Lino, a native of North Shore here in the Coachella Valley and a recent graduate of CSU San Marcos. Thanks to our increased workload with many exciting clients, this year we added a new position of Administrative Assistant and Data Entry Specialist. We were fortunate to find Nicole Smith to fill this position and she has been settling in well as a part of the HARC team.

In addition to these new team members, this fiscal year we celebrated the ten-year anniversaries of both myself and our talented Administrative Manager, Theresa Sama. HARC is lucky to have several employees who have been with us for many years; I credit this to our positive work culture, policies of transparency and equity, and our sense of camaraderie.

HARC Milestones: Fiscal Year 2022-2023

Coachella Valley Community Health Survey

Data for HARC's triennial Coachella Valley Community Health Survey was collected in 2022; the HARC team analyzed the data and used it to create the Executive Report. The 2022 Coachella Valley Community Health Survey Executive Report was released on February 28, 2023, on Zoom. A total of 174 people registered for the event, 94 attended. Video of the event was posted on YouTube on March 7, 2023; to date an additional 39 individuals have viewed the video.

Since the release on February 28, 2023, the electronic version of the report has been downloaded by 105 unique individuals. These people represented a wide variety of organizations, including American Heart Association, Alzheimer's Association, Azusa Pacific University, Borrego Health, Boys & Girls Club of Cathedral City, Boys & Girls Club of Palm Springs, Boys & Girls Clubs of Coachella Valley, CalFresh Healthy Living, California Baptist University, City of Palm Desert, City of Palm Springs, Coachella Valley Volunteers in Medicine, Comite Civico del Valle, Congressman Raul Ruiz, DAP Health, Desert Care Network, Desert Healthcare District and Foundation, Desert Oasis Healthcare, Desert Recreation District, Desert Sands Educational Foundation, Eisenhower Health, FIND Food Bank, First 5 Riverside, Friends of the Desert Mountains, George Mason University, Green Room Theatre Company, Hadassah, Hidden Harvest, Hope Through Housing Foundation, IEHP, Innercare, Institute for Healthcare Advancement, Johnson and Wales University, Joslyn Senior Center, KESQ, Marra Market Intelligence, MPG Wellness Initiative, Olive Crest, OneFuture Coachella Valley, Palm Springs Unified School District, Raices Cultura, Regional Access Project Foundation (RAP), Riverside County Latino Commission on Drug and Alcohol Abuse Services, Riverside County Medical Association, Riverside University Health System – Behavioral Health, Senior Advocates of the Desert, The Desert Sun, The LGBTQ Community Center of the Desert, UC Riverside, and We Are One United, among others.

Most people who downloaded the report used it to prioritize health needs; most reported that their prior use of the data had resulted in increased awareness/knowledge about issues in the community. Six people successfully utilized the data to secure funds and brought in approximately \$767,500.

Press about the data release included print (Desert Sun, Palm Springs Post, Gay Desert Guide), television (KESQ, Desert Chat with Sandie Newton), and radio (Joey English). Printed copies of the report were mailed to HARC's funders, Board Members, and those who requested a printed copy; over 100 have been distributed by the end of FY 22-23.

Additionally, the HARC team, with support from the Windward Fund, analyzed the 2022 survey data to create an environmental justice special report (in English and Spanish). In addition to survey data, the report includes the findings from 24 interviews with residents, with a focus on the Eastern Coachella Valley.

Workplace Wellness Event 2023

HARC hosted the annual Coachella Valley Workplace Wellness Event on June 22, 2023, at the Desert Willow Golf Resort. The event keynote focused on the U.S. Surgeon General's Framework for Workplace Mental Health and Well-Being, followed by a panel on Empowering Wellness that provided insights from local leaders. Over 130 people attended the event. A follow-up satisfaction survey found that the event was viewed positively by attendees.




